### Jorge Fernandez del Valle

Jorge Fernandez del Valle is Director of the Child and Family Research Group (Grupo de Investigación en Familia e Infancia-GIFI) of the University of Oviedo (Spain). Jorge was psychologist and social educator in child residential care from 1981 till 1989.

He coordinated the family intervention program in the social services department of the city of Oviedo until 1992. He started working at the department of social psychology in the University of Oviedo in 1989 as part-time associated lecturer. Since 2010 he works there as a full professor.

### Muireann Ní Raghallaigh

Muireann Ní Raghallaigh is a Lecturer in Social Work at University College Dublin. Muireann developed a keen interest in issues related to and affecting asylum seekers and refugees when working at a social worker with Separated Children Seeking Asylum. Muireann subsequently undertook doctoral research on the experiences of separated asylum seeking children living in Ireland.

Her research focused in particular on the coping strategies used by these young people, including religious coping.

As well as undertaking research in Ireland and in Ethiopia, she has provided training for a number of organisations, including the Jesuit Refugee Service (Malta) and UNHCR (Ireland). Along with the Irish Refugee Council, Tusla and other partners, Muireann is currently involved in an EC funded project on Durable Solutions for separated children.

### Ravi KS Kohli

Ravi KS Kohli is Professor of Child Welfare at Bedfordshire University (UK). Ravi is interested in what becomes of young people who seek asylum in richer countries. He tries and help young people and their carers to make sense of how they came into contact with each other, and what to do for the best now that they are together. His research interests lie amongst others within social work and the resettlement of unaccompanied asylum seeking young people, including those in foster care. Ravi participated in the study on foster care for unaccompanied asylum seeking and refugee children that was lead by Jim Wade and Ala Sirriyeh within the Social Policy Research Unit at York University from 2008-2011.

### Jim Wade

Jim Wade is a Senior Research Fellow at the Social Policy Research Unit of York University (UK). Jim has a background in youth and community work and social work with teenagers. Since entering research in 1990 he has developed a broad interest in social work services for teenagers, including young people in and leaving care, young runaways from home or care and unaccompanied asylum seeking children. He has been involved in the development of national guidance and service standards in relation to leaving care and young runaways. He lead a study on foster care for unaccompanied asylum seeking and refugee children that was carried out in association with the British Association of Adoption and Fostering (BAAF) from 2008-2011.
